#### 1. Risk of Securities Trading 證券交易的風險

The prices of securities fluctuate, sometimes dramatically. The price of a security may move up or down, and may become valueless. You should therefore carefully consider whether such a financing arrangement is suitable in light of your own financial position and investment objectives.
